



IIC LAKSHYA PROGRAM FEE AND REFUND POLICY

Payment Terms

- A. Learners must pay 100% of the course fees before the batch start date or within seven days of paying the admission Fee, whichever is earlier.
- B. Access to the Learning Management System (LMS) will be granted only after the invoice amount is realized for wire transfer or NEFT payments.

Refund Policy

If a learner requests a refund before the batch start date, an Administration Fee of 1000 AED will be deducted, and the balance will be refunded.

Refund requests raised after the class start date shall not be entertained under any circumstances.

Loan or EMI Customers

Loans are facilitated between financial partners and customers, and IIC Lakshya shall not be liable for any disputes arising between them.

In case of non-payment of installment amounts to the financial partner, IIC Lakshya reserves the right to temporarily suspend the learner's subscription until payment confirmation is received from the financial partner.

Documentation

Learners are required to preserve the receipt of payment and produce it upon demand.

Non-Refundable/Transferable Fees

Course fees are non-refundable and non-transferable under any circumstances.

Terms and Conditions
